PROJECT LOCATION: 50 West Beverly Park Way

REQUESTED ACTION: The Zoning Administrator will consider:

- 1. Pursuant to Section 12.27 of the Los Angeles Municipal Code (LAMC), a **Zone Variance** to permit a building height of up to 58 feet in lieu of the 45-foot height limit established in LAMC Section 12.21.1-A for the RE40 Zone.
- 2. Pursuant to Section 12.27 of the LAMC, a **Zone Variance** to permit a second kitchen in a single-family dwelling in lieu of the one kitchen limitation established in LAMC Sec. 12.09.
- 3. Pursuant to Section 12.28 of the LAMC, a **Zoning Administrator's Determination** to permit a third retaining wall in lieu of the two retaining wall limitation established in LAMC Section 12.21-C,8.
- 4. Pursuant to Section 12.28 of the LAMC, an **Adjustment** to allow a front yard wall structure up to a maximum height of 15-foot, 6 inches in lieu of the 3-foot, 6-inch limitation established in LAMC Section 12.21-C,1(g).

- 5. Pursuant to Section 12.28 of the LAMC, an **Adjustment** to allow a rear yard wall structure up to 10 feet in lieu of the maximum 6-foot high wall limitation established in LAMC Section 12.21-C,1(g).
- 6. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of the California Environmental Quality Act (CEQA).

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
