PROJECT:The proposed project involves the demolition of a 3,653-square-foot, one-story, single-family dwelling with an attached garage and the construction of an approximately 4,003-square-foot, one-story, single-family dwelling with a 2,785 square-foot basement including two retaining walls and attached 440 square-foot, two-car garage. The project proposes a total of two covered and one uncovered on-site parking spaces and a maximum building height of 15'-0" in the single permit jurisdiction area of the Coastal Zone.

ACTION:

1. Pursuant to Section 12.20.2 of the Municipal Code, a **Coastal Development Permit** and Mello Act Compliance Review for the proposed demolition of a 3,653square-foot, one-story, single-family dwelling with an attached garage and the construction of an approximately 4,003-square-foot, one-story, single-family dwelling with a 2,785 square-foot basement including two retaining walls varying from 3'-6" to 10 feet and attached 440 square-foot, two-car garage, a total of two covered and one uncovered on-site, parking spaces and a maximum building height of 15'-0", located in the single permit jurisdiction area of the Coastal Zone.

- 2. Pursuant to Government Code Sections 65590 and 65590.1 a **Mello Act Compliance Review** for the demolition and new construction of a Residential Unit in the Coastal Zone.
- 3. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of the California Environmental Quality Act (CEQA).

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
