**REQUESTED ACTION:** The Zoning Administrator will consider:

- 1. Pursuant to Los Angeles Municipal Code Section 12.24-M, Approval of Plans to allow the continued sale and dispensing of a full line of alcoholic beverages for on-site consumption in conjunction with an existing 2,466 square-foot restaurant with 82 indoor seats in lieu of previously approved under Case No. ZA 2011-0213(CUB). Proposed hours of operation are from 8:00 a.m. to 2:00 a.m., daily.
- 2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The purpose of this hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
