**REQUESTED ACTION:** The Zoning Administrator will consider:

- 1. Pursuant to Los Angeles Municipal Code 12.24-W, 1, a Conditional Use Permit to allow the sale of and dispensing of beer and wine for on-site and off-site consumption in conjunction with a proposed 5,587 square-foot brewery/restaurant with a 600 square-foot patio with 104 indoor seats and 24 outdoor patio seats, partially in the right of way. Proposed hours of operation are 11:00 a.m. to 2:00 a.m., daily.
- 2. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration (MND) for the above referenced project.

The purpose of this hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**Exhaustion of Administrative Remedies:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record.
