PROPOSEDThe proposed project is the continued use and maintenance of an existing 2,958 square-foot
automotive repair and body shop facility with hours of operation from 8:00 a.m. to 7:00 p.m.
Monday through Friday and from 8:00 a.m. to 6:00 p.m. Saturday.

REQUESTED ACTION: The Zoning Administrator will consider:

- 1. Pursuant to Section 12.27 of the Los Angeles Municipal Code, a Variance to allow an automotive repair and body shop use in the [Q]C2-1VL Zone, as otherwise prohibited by Ordinance No. 176825.
- 2. Based on the whole of the administrative record, the Project is exempt pursuant to CEQA Guidelines, Section 15330 (Class 1, Category 22 of the City CEQA Guidelines), and there is no substantial evidence demonstrating that an exception to a categorical exemption pursuant to CEQA Guidelines, Section 15300.2 applies.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion Of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
