PROJECT LOCATION: 1301, 1311, 1317 North Western Avenue; and 5501 West Fountain Avenue

REQUESTED ACTION: The Zoning Administrator will consider:

1. Pursuant to the provisions of Section 12.24-W,49 of the Los Angeles Municipal Code, a Conditional Use to permit the installation, use, and maintenance of an unmanned wireless telecommunications facility consisting of a 53-foot in height mono-pole disguised as a palm tree, with three (3) antenna array sectors, and associated equipment, cabinets, and back-up generator installed and maintained within a 400 square-foot ground level lease area located at the northwest corner of an existing parking lot for a homeless shelter and services center in the C2-1 Zone.
2. Based on the whole of the administrative record, the Project is exempt pursuant to California Environmental Quality Act (CEQA) Guidelines, Section 21084, and City Exemption Class 3 Category 4,

and there is no substantive evidence demonstrating that an exception to a Categorical Exemption pursuant to CEQA Guidelines, Section 15300.2 applies.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion Of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.

Section 704 of Title 7 of the Federal Telecommunications Act of 1996 (effective February 8, 1996), contains the following language:

"IV. No State or local government or instrumentality thereof may regulate the placement, construction, and modification of personal wireless service facilities on the basis of the environmental effects of radio frequency emissions to the extent that such facilities comply with the Commission's regulations concerning such emissions."
