REQUESTED ACTION: The Zoning Administrator will consider:

- Pursuant to Los Angeles Municipal Code Section 12.24X.7, a Determination to allow the construction 1. and maintenance of a 7'-8" wrought-iron fence, a 7'-0" hedge, 8'-0" brick pilasters, a 6'-0" driveway gate, and a 6'-0" concrete masonry wall within the front yard setback in lieu of the 3'-6" inch maximum height permitted by LAMC Section 12.22C.20(f)(2) in the RE20 Zone.
- Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has 2. been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of the California Environmental Quality Act (CEQA).

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
