**PROJECT LOCATION:** 17526 W. Tramonto Drive, legally described as: Lot: 10, Block: 16, Tract: 8923.

**PROPOSED PROJECT:** The proposed project involves: (1) a lot line adjustment between 17526 W. Tramonto Drive and 17538 W. Tramonto Drive; and (2) an after-the-fact permit for existing retaining walls of varying heights in the landside area of the subject property (the existing retaining walls were repaired and upgraded in 2006; no additional alterations of the existing retaining walls are proposed), located in the dual permit jurisdiction area of the Coastal Zone.

**REQUESTED ACTION:**

1. Pursuant to Section 12.20.2 of the Los Angeles Municipal Code, a **Coastal Development Permit** for approvals of: ((1) a lot line adjustment between 17526 W. Tramonto Drive and 17538 W. Tramonto Drive; and (2) an after-the-fact permit for existing retaining walls of varying heights constructed in a landside area of the subject property, located in the dual permit jurisdiction area of the Coastal Zone.

2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of the California Environmental Quality Act (CEQA). Pursuant to Article III, Section I, Class 3, Category 6 (Small Structures; Retaining Wall) and Class 5, Category 1 (Alterations in Land Use Limitations; Minor Lot Line Adjustments) of the City of Los Angeles CEQA Guidelines.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**EXHAUSTION OF ADMINISTRATIVE REMEDIES:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
