ACTION:

- 1) Pursuant to the Los Angeles Municipal Code Section 17.03, Vesting Tentative Tract Map No. 73939 for the subdivision of three air space lots on a 98,637 square-foot lot in the [T][Q]RAS4-1 Zone.
- 2) Find under the California Public Resources Code Section 21166 and the State's Environmental Quality Act (CEQA) Guidelines Section 15162, on the basis of substantial evidence contained in the whole record, that since certification of EIR No.

ENV-2005-6164-EIR (SCH No. 2008041053), as updated by subsequent addendums, there have been no changes to the project, changes with respect to the circumstances under which the project is being undertaken, or new information of substantial importance concerning the project, which cause new significant environmental effects or a substantial increase in the severity of previously identified significant effects, and therefore no additional environmental review is required for the project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
