PROPOSED A vesting tentative tract map for the merger of two lots and re-subdivision into 8 small lots, each with a single-family dwelling unit and 2 parking spaces, on a 9,944 square foot project site. The Certificates of Occupancy list two existing single-family houses on-site which would be demolished. The site has been altered to contain 10 unpermitted dwelling units.

REQUESTED The Deputy Advisory Agency will consider:

ACTION:

1. Based on the whole of the administrative record, the Project is exempt pursuant to CEQA Guidelines, Section 15332, and there is no substantial evidence demonstrating

that an exception to a categorical exemption pursuant to CEQA Guidelines, Section 15300.2 applies.

2. Pursuant to Sections 17.03, 17.10.1 and 12.22-C,27 of the Los Angeles Municipal Code (LAMC), consideration of a Vesting Tentative Tract Map for a merger and resubdivision into Small Lots.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
