PROPOSED PROJECT:

Remodel and addition to a one-story, 1,015 square-foot single-family dwelling consisting of a 17.25 square-foot groundfloor addition and a new 1,322 square-foot second floor with a 132 square-foot balcony; the project provides a total of four parking spaces.

REQUESTED ACTION:

- 1. Pursuant to Section 12.20.2 of the Municipal Code, a Coastal Development Permit for the remodel and addition resulting in a two-story single-family dwelling, within the single jurisdiction of the California Coastal Zone.
- 2. Pursuant to Section 11.5.7 of the Municipal Code, a Project Permit Compliance Review for a project within the Venice Coastal Zone Specific Plan.
- 3. Pursuant to Section 21804 of the California Public Resources Code, the above

referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
