The Central Area Planning Commission invites you to attend a hearing regarding the property highlighted above. The law requires that owners and renters near this site be notified of this hearing. If you do not wish to attend the hearing, you may ignore this notice.

Pursuant to California Government Code section 54960.1, the Central Los Angeles Area Planning Commission will hold a new hearing on this project.

<u>The hearing involves an appeal</u> of the Zoning Administrator's decision, pursuant to Los Angeles Municipal Code Section (LAMC) 12.24-L, to approve plans for the upgrade of alcoholic beverage sales and dispensing from beer and wine to a full line of alcohol beverages for on-site consumption in conjunction with an existing restaurant in the C1-1D Zone, and pursuant to LAMC 12.24-W 27, to approve a Conditional Use Permit to deviate from LAMC Section 12.22-A 23, to allow hours of operation to be 10:00 A.M. to 12:00 A.M. Sunday - Thursday and 10:00 A.M. to 2:00 A.M. Friday -Saturday in lieu of the operating hour restrictions for Mini-Shopping Centers in the C1-1D Zone, and find that the project is Categorically Exempt (ENV-2016-1010-CE) from the environment review pursuant to Article III, Section 1, and Class 5, Category 34 of the City of Los Angeles CEQA Guidelines.

**TESTIMONY:** Written testimony may be submitted prior to the hearing (see Correspondence and Exhibits); however, oral testimony **can only be given at the hearing** and may be limited due to time constraints. Language translators, sign language interpreters, and/or assistive listening devices may be provided if you contact the Planning Commission office at least seven (7) days prior to the hearing date.

<u>DECISION</u>: The Commission's decision will be based on the merits of the case and the applicable law. The Commission can consider the entire action even if only a portion has been appealed. A report of the Commission's action will be mailed upon request after the hearing. Pursuant to Government Code Section 65009(b)(2), any court challenge of the Commission's action may be limited to those issues considered at the public hearing.

<u>FILE REVIEW</u>: The complete and permanent file (including all submissions) is available for public inspection in the Commission office, **Room 532**, 200 N. Spring Street, Los Angeles, between the hours of 8:00 a.m. to 4:00 p.m., Monday through Friday. Please call in advance to ensure file availability (213-978-1300).

### **CORRESPONDENCE AND EXHIBITS**

The Commission members are not City employees. They are citizens who have been appointed by the Mayor. They function in a quasi-judicial capacity and therefore, cannot be contacted before the hearing. Written testimony, for the Commission to consider, may be submitted to the Planning Commission Office using the following guidelines:

- 1. Materials for Commission consideration should be received <u>ten (10) days</u> prior to the hearing date.
- 2. Please provide an **original** plus **twelve (12) copies** of all correspondence or exhibits. Correspondence should be presented on letter size (8 ½" x 11") or legal size (8 ½" x 14"). All oversized exhibits (photos, plans, artists' renderings) must fold to fit into a legal sized folder.
- 3. It is important that the case number is written on all communications and exhibits.
- 4. Any materials submitted to the Commission become City property and <u>will not</u> be returned. This includes any correspondence or exhibit used as part of your testimony to the Planning Commission.
- 5. Untimely submissions <u>will not</u> be considered by the Commission, but will be added to the permanent file.
