PROPOSED PROJECT: The proposed project involves the remodeling and addition to an existing one-story 1,144 square foot single-family dwelling and attached 316 square foot garage, resulting in adding 1,342.6 square feet to the dwelling and new 445 square foot attached garage, located in the single permit jurisdiction of the Coastal Zone.

REQUESTED ACTION:

1. Pursuant to Section 12.20.2 of the Los Angeles Municipal Code, a Coastal Development Permit for the proposed remodeling and addition to an existing 1,144 square foot single-family dwelling and demolition of an attached 316 square foot garage, resulting in adding 128.8 square feet to the first floor and a new second story of 1,214.6 square feet, new 445 square foot attached garage, and new retaining walls, all located in the single permit jurisdiction of the Coastal Zone.

- 2. Pursuant to Government Code Sections 65590 and 65590.1, a Mello Act Compliance Review for the abovementioned project in the Coastal Zone.
- 3. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of the California Environmental Quality Act (CEQA). Pursuant to Article III, Section I, Class 3, Category 1 of the City of Los Angeles CEQA Guidelines.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
