REQUESTED ACTION:

The Zoning Administrator will consider:

- 1. Pursuant to the provisions of Section 12.27.B of the Municipal Code, a Zone Variance from Section 12.14 to allow an enclosed auto body spray booth within 500 feet of a residential zone.
- 2. Pursuant to Section 21084 of the California Public Resources Code and Article 19 Section 15301 (Existing Facilities) of the State CEQA Guidelines, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.
