REQUESTED ACTION: The Zoning Administrator will consider:

- 1. Pursuant to the provisions of Section 12.24 X 7 of the Los Angeles Municipal Code, a Zoning Administrator Adjustment to allow an 8 foot in height fence wall and gate within the front yard setback that encroaches on the unimproved public right of way in lieu of the required maximum height of 3 feet 6 inches by Code Section 12.21-C.1(g) and 12.21-C.10(a)10 for a new single family dwelling, and
- Based on the whole of the administrative record, the Project was issued ENV-2014-3010-MND on February 11, 2015 for the entire development project of this new single family dwelling under CEQA requirements.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will and the merits of the project as it relates to existing environmental and land use regulations.
