**PROJECT LOCATION:** 938 West Amoroso Place

**PROPOSED PROJECT:** The proposed project involves the remodeling and addition to an existing single-family dwelling on a Venice Walk Street.

**REQUESTED ACTION:** The Zoning Administrator will consider:

- 1. Pursuant to Section 12.20.2 of the Municipal Code, a Coastal Development Permit to permit the remodeling and addition to an existing one-story 948 square foot single-family dwelling and 198 square foot detached garage, to create a two-story 28-foot tall 2,482 square foot single-family dwelling with attached 356 square foot garage located in the single permit jurisdiction area of the Coastal Zone.
- 2. Pursuant to the provisions of Section 12.28 of the Los Angeles Municipal Code, a Zoning Administrator's Adjustment to allow a 0-foot rear yard in lieu of the 15-foot rear yard required by Section 12.09-C, and
- 3. Pursuant to Section 11.5.7 of the Municipal Code, a Project Permit Compliance Review for a project within the Venice Coastal Zone Specific Plan.

- 4. Pursuant to Government Code Sections 65590 and 65590.1, a Mello Act Compliance Review for the proposed project located in the Coastal Zone
- 5. Pursuant to Section 21804 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA, under ENV-2016-4642-CE. Pursuant to Article III, Section I, Class 1, Category 1 of the City of Los Angeles CEQA Guidelines.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**Exhaustion Of Administrative Remedies:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record.
