PROPOSED PROJECT:

The proposed project involves the remodel of an existing one-story single-family dwelling with a basement garage with the addition of approximately 1,762 square feet on the first level for a total floor area 3,630 square feet, and a maximum height of 28 feet and 8 inches, in the dual-permit jurisdiction area of the Coastal Zone.

REQUESTED ACTIONS:

- 1. Pursuant to Section 12.20.2 of the Municipal Code, a **Coastal Development Permit** authorizing the remodel of an existing one-story single-family dwelling with a basement garage with the addition of approximately 1,762 square feet on the first level for a total floor area 3,630 square feet, and a maximum height of 28 feet and 8 inches, in the dual-permit jurisdiction area of the Coastal Zone.
- 2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the
