PROPOSED PROJECT:

The demolition of an existing fast-food restaurant and ancillary drive-through and the construction, use and maintenance of a new fast-food restaurant and ancillary drive-through with dining room hours of operation from 5 a.m. to 1 a.m. daily and 24-hour drive-through

operations daily.

REQUESTED ACTIONS:

- 1) Pursuant to Los Angeles Municipal Code (LAMC) Section 12.24-W,17, a Conditional Use to allow the operation of a drive-through fast-food restaurant on a lot that adjoins a residentiallyzoned lot: and
- 2) Pursuant to Section 21084 of the California Public Resources Code, the abovereferenced project has been determined not to have a significant effect on the environment and which shall, therefore, be exempt from the provisions of CEQA. The project was issued a Categorical Exemption, Class 2, Category 2.
