PROJECT LOCATION: 1818 North Old Ranch Road

REQUESTED ACTION: The Zoning Administrator will consider:

1. A Zoning Administrator's Adjustment per Section 12.28 of the Los Angeles Municipal Code for relief from Code Section 12.21-C,5(a) and (b) to permit an existing animal keeping structure and shed to be located within 55-feet of the front lot line and within the front half of the lot, and to allow a 3-foot 11-inch side yard in lieu of the required 25-foot side yard, and
2. Pursuant to Section 12.24-X,28 of the Code, a Zoning Administrator's Determination to allow a 1-foot front yard in lieu of the 25-foot front yard required by Section 12.21-C,10(a), all in conjunction with the continued use of the abovementioned structures on a 26,288 square foot lot zoned RE40-1-H.
3. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion Of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.

Advice To Public: The exact time this report will be considered during the meeting is uncertain since there may be several other items on the agenda.
