**REQUESTED ACTION:** The Zoning Administrator will consider:

- 1. Pursuant to Section 12.24-W, 1 of the Los Angeles Municipal Code, a Conditional Use Permit to allow the upgrade from a beer and wine license to the sale and dispensing of a full line of alcoholic beverages for on-site consumption in conjunction with 26,471 square-foot theater with 1,096 indoor seats and a 6,147 square-foot roof deck with 240 outdoor seats featuring live entertainment and dancing as previously approved by Case No. ZA 2011-0724(CUB)(CUX) with hours of operation 24-hours, daily.
- 2. Pursuant to Section 21084 of the California Public Resources Code, adopt the reconsideration to previously issued Mitigated Negative Declaration (ENV-2011-725-MND-REC1) of the above reference case.

The purpose of this hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
