**REQUESTED ACTION:** The Zoning Administrator will consider:

- 1. Pursuant to Section 12.24-M of the Los Angeles Municipal Code, modification of the Zoning Administrator's approval of a Conditional Use Permit for the Phoenix House residential private high school and drug abuse center to create a new service driveway, a net increase of 10 parking spaces for a total of 127 spaces (108 spaces required) and a replacement basketball court. No operational changes are proposed. In addition, the applicant is requesting to revise Conditions No. 14, 15 and 25 and to delete Condition 12.c of ZA-92-777-CUZ-PA7,
- 2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of the California Environmental Quality Act (CEQA).

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**EXHAUSTION OF ADMINISTRATIVE REMEDIES:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record.
