PROJECT LOCATION: 14252 West Friar Street

REQUESTED ACTION: The Zoning Administrator will consider:

1. Pursuant to Los Angeles Municipal Code (LAMC) 12.27B, a Zone Variance to allow three parking spaces in lieu of four parking spaces as otherwise required per LAMC Section 12.21 A.4, in conjunction with the conversion of an existing garage, with attached storage room and guest room, to a second dwelling unit.
2. Pursuant to LAMC 12.28, a Zoning Administrator's Adjustment to allow automobile parking within the front yard setback not otherwise permitted per LAMC Section 12.21 C.1(g).
3. Pursuant to LAMC 12.28, a Zoning Administrator's Adjustment to allow a 1-foot side yard and 1-foot rear yard in lieu of 5 feet and 15 feet, respectively, for the converted second dwelling unit in the [Q]RD1.5-1 Zone, not otherwise permitted per LAMC Section 12.09.1 B.2 and B.3..
4. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of the California Environmental Quality Act (CEQA). Pursuant to Article III, Section I, Class 3, Category 1 of the City of Los Angeles CEQA Guidelines.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The Associate Zoning Administrator will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Department before the action on this matter, which will become a part of the administrative record. Note: This may not be the last hearing on this matter.
