**REQUESTED ACTION:** The Zoning Administrator will consider:

Pursuant to Section 12.26 K of the Los Angeles Municipal Code, a Director of Planning Determination as to whether the Department of Building and Safety erred or abused their discretion in issuing Building Permit No.16010-30000-00108 for the construction of a new two-story, 1,196 square-foot, second dwelling unit with an attached garage on the grounds that the project fails to comply with LAMC Section 12.24 W. 43 and ZA Memorandum 120 is invalid.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this appeal. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the appeal as it relates to Chapter I of the Los Angeles Municipal Code and land use ordinances adopted by the City Council.

**Exhaustion Of Administrative Remedies:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
