REQUESTED ACTION: The Zoning Administrator will consider:

1. Pursuant to the provisions of Section 13.01-H of the Los Angeles Municipal Code and condition Nos. 8 and 10 of ZA-1965-17828(PA3), a Zoning Administrator's Approval of Plans to review the applicant's compliance with and the effectiveness of the conditions imposed under ZA-1965-17528(PA3).
2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA. (Categorical Exemption, Article III, Section 1, Class 21, Category 2)

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding the operation of the facility pursuant to the conditions imposed under ZA-1965-17528(PA3). The action to hold the hearing and

review applicant's compliance is exempt from CEQA pursuant to CEQA Guidelines Section 15321 (Class 21). The environmental clearance for any Plan Approval will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the status of the operations relative to existing environmental and land use regulations and the conditions established in the grant ZA-1965-17528 (PA3).

Exhaustion Of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.

Advice To Public: The exact time this report will be considered during the meeting is uncertain since there may be several other items on the agenda. Written communications may be mailed to the Los Angeles City Planning Department, 200 N. Spring Street, Los Angeles, CA 90012 (attention: Alan Como).

Review Of File: The file, including the application and the environmental assessment, are available for public inspection at this location between the hours of 8:00 a.m. to 4:00 p.m., Monday through Friday. Please call (213) 473-9985 several days in advance to assure that the files will be available. The files are not available for review the day of the hearing.
