REQUESTED ACTION: The Zoning Administrator will consider:

1. Pursuant to the provisions of Section 12.24 X 26 of the Los Angeles Municipal Code, a **Zoning Administrator's Determination** to allow a third retaining wall exceeding the maximum required number with a wall height of 8 feet and a 3 foot 6 inch for a guardrail totaling 11 feet 6 inches at its highest point, LAMC Sections 12.21 C 8 and 12.24, and
2. Pursuant to the provisions of Section 12.28 A of the Los Angeles Municipal Code, a **Zoning Administrator's Adjustment** to allow an 11 foot 6 inch wall within the side yard setback of a Hillside area to exceed 8 feet in height, LAMC Section 12.22 C.20(f)(3), and
3. Pursuant to the provisions of Section 12.28 A of the Los Angeles Municipal Code, a **Zoning Administrator's Adjustment** to allow a detached deck to encroach in the required side yard setback, LAMC Section 12.07.01 C.2(b)
4. Based on the whole of the administrative record, the Project was issued ENV-2016-3968-CE on November 18, 2016 for the retaining wall and detached deck under CEQA requirements.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion Of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.

Advice To Public: The exact time this report will be considered during the meeting is uncertain since there may be several other items on the agenda.
