**REQUESTED ACTION:** The Zoning Administrator will consider:

- Pursuant to the provisions of Section 12.28A of the Los Angeles Municipal Code, a Zoning Administrator's Adjustment to allow a seven foot and one inch northern side yard and a nine foot, two-inch southern side yard in lieu of the 12-foot side yards required by Section 12.09 C.2 of the Code in conjunction with the construction of a 43-foot and 10 inches feet in height, 2,651 square foot single-family dwelling on a vacant lot in the RE20-1 Zone;
- 2. Determined that based on the whole of the administrative record, the Project is exempt pursuant to CEQA Guidelines 15300 *et seq.* Article III, Section 1, Class 5, Category 10 (Minor area variances, building location and configuration variances, yard variances, or slight modifications which do not result in any change in land use or additional dwelling units.)

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**Exhaustion Of Administrative Remedies:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
