The project proposes the demolition of two commercial buildings and two residential buildings, and the construction, use, and maintenance of an approximately 880 square-foot drive-through coffee shop (Starbucks) with eight outdoor patio seats. The proposed structure is one-story and approximately 20 feet high. Nine automobile parking spaces will be provided within an on-site surface parking lot. The drive-through Starbucks coffee shop proposes to operate between the hours of 5:00 a.m. and 12:00 a.m. daily.
