**REQUESTED ACTION:** The Zoning Administrator will consider:

1. Pursuant to the provisions of Section 12.24-W, 1, of the Los Angeles Municipal Code, a Conditional Use Permit to continue the sale and dispensing of beer and wine for on-site consumption in conjunction with an existing 1,494 square-foot restaurant with 51 indoor seats, and a 396 square-foot covered outdoor seating area with 20 seats within the public right-of-way.

2. Pursuant to the provisions of Section 12.24-W, 27, of the Los Angeles Municipal Code, a Conditional Use Permit to allow the hours of operation of 11:00 a.m. to 12:00 a.m. Sunday through Thursday and 11:00 a.m. to 1:00 a.m. Friday and Saturday in lieu of the hours of 7:00 a.m. to 11:00 p.m. as restricted by Mini Shopping Center regulations.

3. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The purpose of this hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

<u>Exhaustion of Administrative Remedies</u>: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
