**PROJECT LOCATION:** 2945 North Eagle Rock Boulevard

**PROPOSED PROJECT:** The proposed project is the demolition and remodel of a former church facility for the construction and improvement of a 8,492 square foot swim school and aquatic community center.

**REQUESTED ACTION:** The Zoning Administrator will consider:

1. Pursuant to the provisions of Section 14.00 B of the Los Angeles Municipal Code, a Public Benefit Alternative Compliance request for a community center in an R Zone;
2. Pursuant to the provisions of Section 12.28 of the Los Angeles Municipal Code, a Zoning Administrator's Adjustment to allow a public parking area to extend into that portion of the subject lot within 10 feet of the front lot line;

3. Pursuant to the provisions of Section 13.08 of the Los Angeles Municipal Code, a Community Design Overlay (CDO) approval for the demolition and remodeling of a former church facility and the construction and improvement of a swim school and aquatic community center in the Cypress Park and Glassell Park CDO area;
4. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration (ENV-2015-4092-MND) for the above referenced project; and,
5. Pursuant to Section 21081.6 of the California Public Resources Code and Section 15097 of the California Environmental Quality Act (CEQA) Guidelines, adopt the Mitigation Monitoring Program (MMP) for ENV-2015-4092-MND.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**Exhaustion Of Administrative Remedies:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.

**Advice To Public:** The exact time this report will be considered during the meeting is uncertain since there may be several other items on the agenda.
