PROJECT:The construction, use and maintenance of a new two-story, 3,084 square-foot single
family residence with an attached garage and roof deck with three vehicular parking
spaces, in conjunction with the demolition of an existing single-family dwelling.

ACTION: 1. Pursuant to Section 12.20.2 of the Municipal Code, a **Coastal Development Permit** authorizing the construction, use and maintenance of a new two-story, 3,084 square-foot single family residence with an attached garage and roof deck with three vehicular parking spaces, and a maximum height of 25 feet in the Southeast Venice Subarea, within the dual-permit jurisdiction of the California Coastal Zone.

- 2. Pursuant to Section 11.5.7 of the Municipal Code, a **Project Permit Compliance Review** for a project within the Venice Coastal Zone Specific Plan.
- 3. Pursuant to Government Code Sections 65590 and 65590.1 a **Mello Act Compliance Review** for new construction of a Residential Unit in the Coastal Zone.
- 4. Pursuant to Section 21804 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA. Pursuant to Article III, Section I, Class 3, Category 1 of the City of Los Angeles CEQA Guidelines.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
