REQUESTED ACTION: The Zoning Administrator will consider:

- 1. Pursuant to the provisions of Section 12.24 X.26 of the Los Angeles Municipal Code, 1) a Zoning Administrator's Determination to permit four (4) retaining walls in lieu of a maximum of two (2) permitted by Section 12.21 C.8(a); pursuant to Section 12.24 X.28 of the LAMC, a Zoning Administrator's Determination 2) to permit two (2) parking spaces for a new single-family dwelling with over 2,400 square feet of floor area in lieu of three (3) parking spaces otherwise required by Section 12.21 C.10(g)(2); and, pursuant to Section 12.28 of the LAMC, 3) a Zoning Administrator's Adjustment to permit an 8-foot wide passageway from the street to the main entrance in lieu of the 10 feet otherwise required by section 12.21 C.2(b), all in conjunction with the construction, use, and maintenance of a new, two-story, 2,516 square foot single-family dwelling.
- Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adoption of the Mitigated 2. Negative Declaration, ENV-2015-1568-MND, for the above-referenced project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion Of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
