REQUESTED ACTION: The Zoning Administrator will consider:

1. Pursuant to the provisions of Section 12.24.X.27 of the Los Angeles Municipal Code, a Zoning Administrator's Determination to allow the continued use and maintenance of an existing non-conforming grocery store selling beer and wine for off-site consumption in the RD2-1 Zone.
2. Pursuant to the provisions of Section 12.24.W.1 of the Los Angeles Municipal Code, a renewal of a Conditional Use to allow the sale of beer and wine for off-site consumption at an existing grocery store
3. Pursuant to Section 21084 of the California Public Resources Code and Article III Class 5 (Alteration in Land Use Limitations), Category 23 (Granting/Renewal of Conditional Use) of the City CEQA

Guidelines, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
