REQUESTED ACTION: The Zoning Administrator will consider:

- 1. Pursuant to Charter Section 5262 and Section 12.27 of the Los Angeles Municipal Code, a Variance from Section 12.09.1 A of the Municipal Code for a commercial market use in the RD Zone.
- 2. Based on the whole of the administrative record, the Project is exempt pursuant to CEQA Guidelines, Section 15305 (Class 5, Category 13 of the City CEQA Guidelines), and there is no substantial evidence

demonstrating that an exception to a categorical exemption pursuant to CEQA Guidelines, Section 15300.2 applies.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
