The construction of a 17 feet in height retaining wall in the rear yard in conjunction with

REQUESTED ACTIONS:

The Zoning Administrator will consider:

1. Pursuant to Section 21084 of the California Public Resources Code and State CEQA Guidelines 15300 and City CEQA Guidelines Article III, Section 1, Class 3, Category 6 (Accessory Structures), the above referenced project has been determined not to have a significant effect on the environment and a Categorical Exemption has been issued for the project described above, and there is no substantial evidence demonstrating that an exception to a categorical exemption, pursuant to CEQA Guidelines Section 15300.2, applies.

- 2. Pursuant to LAMC Section 12.24-X,26, a **Determination** to permit a 17 feet in height retaining wall in lieu of the maximum 12 feet otherwise permitted in the Hillside Area, in the R1 Zone;
- 3. Pursuant to LAMC Section 12.28, an **Adjustment** from Section 12.08-C,3 to permit a retaining wall in the rear yard, in the R1 Zone;

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
