SUMMARY OF DISCUSSION

The City Planner, Sarah Hounsell, went over the proposed project in accordance with the small Lot Ordinance. The planner announced the technical correction to the Staff's Recommendation Report. The Commission opened the floor for the public comment period. The applicant's representative gave detail description of the proposed project and its usage. The public comment period was closed, and the Commission began deliberation.

Commissioner Dierking put forth the following motion, seconded by Commissioner Bishop relative to the approval of the following project:

The grading of the existing site and the construction, use and maintenance of 24 single-family homes in accordance with the Small Lot Ordinance.

- 1. **FIND**, pursuant to CEQA Guidelines Section 15074(b), after consideration of the whole of the administrative record, including the Mitigated Negative Declaration, No. ENV-2014-1616-MND ("Mitigated Negative Declaration"), and all comments received, with the imposition of mitigation measures, there is no substantial evidence that the project will have a significant effect on the environment; **FIND** the Mitigated Negative Declaration reflects the independent judgment and analysis of the City; **FIND** the mitigation measures have been made enforceable conditions on the project; and b the Mitigated Negative Declaration and the Mitigation Monitoring Program prepared for the Mitigated Negative Declaration;
- 2. **APPROVE** a Zone Change, pursuant to LAMC Section 12.32 F, from R3-1, (T)R3-1, [Q]RD1.5-1, and R1-1 to (T)(Q)RD1.5-1 and (T)(Q)RD5-1 with the new zone replacing the old "Q" Condition:
- 3. **APPROVE**, pursuant to LAMC Section 12.27, a Zone Variance from Sections 12.09.1 A and 12.21 C 5 (h) to allow vehicular access from a less restrictive zone (RD1.5 Zone) to a more restrictive zone (RD5 Zone) permitting guest parking and common driveway and pedestrian access across the site.
- 4. **ADOPT** the Conditions of Approval recommended by staff, including the technical correction as stated on the record; and
- 5. **ADOPT** the Findings.
