**REQUESTED ACTION:** The Zoning Administrator will consider:

- 1. Pursuant to Section 12.24-W, 1, of the Los Angeles Municipal Code, a Conditional Use Permit to allow the continued sale and dispensing of a full-line of alcoholic beverages for on-site consumption in conjunction with an existing 4,259 square-foot restaurant with 104 indoor seats, 28 seats indoor seats in a 860 square-foot basement room, 20 outdoor seats on a 260 square-foot front dining patio, and 16 outdoor seats on a 270 square-foot rear dining patio, with proposed hours of operation from 11:00 a.m. to 2:00 a.m., daily, in the C4-2D-SN Zone.
- 2. Pursuant to 12.24–W, 18, of the Los Angeles Municipal Code, a Conditional Use Permit to allow the continuation of public dancing and live entertainment in conjunction with the existing restaurant; and

 Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt a reconsideration of the previously adopted Mitigated Negative Declaration (MND) ENV Case No. ENV-2008-3711(MND) for the above referenced project.

The purpose of this hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**Exhaustion of Administrative Remedies:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record.
