REQUESTED ACTION(S):

- Pursuant to Charter Section 562 and Los Angeles Municipal Code (LAMC) Section 12.27 B, a Zone Variance to permit 35 parking spaces in the MR2-1 zone in lieu of the 46 parking spaces required for the currently permitted floor area of 22,980 square feet and an additional 3 parking spaces if the existing 1,400 square-foot unpermitted addition is legalized.
- 2. Based on the whole of the administrative record, the Project is exempt from CEQA pursuant to CEQA Guidelines, Article III, Section 1, Class 1, Category 22, for granting or renewal of a variance or conditional use for a non-significant change of use in an existing facility, and there is not substantial evidence demonstrating that an exception to a categorical exemption pursuant to CEQA Guidelines, Section 15300.2 applies.
