## **PROPOSED PROJECT:**

The addition (legalization) of 2 units to an existing 2 unit residential building in the R2-1 zone and the addition of 4 parking spaces at the front of the building. There will be no additional square footage or change in footprint.

## APPEAL:

Appeal of the June 27, 2018, Zoning Administrator's determination to:

- 1. Deny a Zone Variance to allow a residential building of 4-units in lieu of the existing 2-units allowed in the R2-1 Zone per Section 12.09 A.2. of Los Angeles Municipal Code (LAMC);
- 2. Deny a Zoning Administrator's Adjustment, to allow a front yard setback of 0-feet in lieu of the required 20-feet per LAMC Section 12.09 C.1;
- 3. Deny a Zoning Administrator's Adjustment, to allow parking within the front yard setback, as otherwise prohibited by LAMC Section 12.21 C.1 and;
- 4. Deny a Zoning Administrator's Adjustment, to allow over 50 percent of a front yard to be paved, as otherwise prohibited by LAMC Section 12.21 C.1.

## **GENERAL INFORMATION**

**FILE REVIEW** - The complete file is available for public inspection between the hours of 8:30 a.m. to 4:00 p.m., Monday through Friday. Appeal Recommendation Reports will be available online seven (7) days prior to the public hearing and will be accessible at <u>planning.lacity.org</u>, by selecting "Commissions & Hearings". Appeal Recommendation Reports are hyperlinked to the case numbers on the agendas. If you are appealing a determination of an Associate Zoning Administrator (AZA), please note that the letter of determination is the report which is forwarded to the Commission. Appeal Recommendation Reports are not prepared for AZA appeals. The Commission may consider the entire action even if only a portion of the action has been appealed.

**TESTIMONY AND CORRESPONDENCE -** Your attendance is optional; oral testimony can only be given at the hearing and may be limited due to time constraints. Written testimony or evidentiary documentation may be submitted prior to the hearing. Commissions function in a quasi-judicial capacity and therefore, cannot be contacted directly. Any materials submitted to the Department or Commission become City property and <u>will not</u> be returned. This includes any correspondence or exhibits used as part of your testimony.

Be advised that the Commission may RECONSIDER and alter its action taken on items listed on the meeting agenda at any time during this meeting or during the next regular meeting, in accordance with the Commission Policies and Procedures and provided that the Commission retains jurisdiction over the case. If a Commission meeting is cancelled or adjourned due to lack of quorum, all remaining agenda items shall be continued to the next regular meeting or beyond, as long as the continuance is within the legal time limits of the case or cases.

**REQUIREMENTS FOR SUBMISSION OF MATERIALS** - Written testimony may be submitted via email, in person or by U.S. mail to the staff identified on the front of this page. There may be other time limits which also affect your ability to seek judicial review.
