The demolition of an existing 2,615 square-foot one-story single-family dwelling; the construction of a new 3,848 squarefoot one-story single-family dwelling with a basement, partially-subterranean attached four-car garage, swimming pool, and two retaining walls; the associated grading; and a haul route for the export of 1,196 cubic yards of earth.

APPEAL:

Appeal of the Director of Planning's Determination to approve a Coastal Development Permit authorizing the demolition of an existing one-story single-family dwelling; the construction of a new one-story single-family dwelling with a basement, partially-subterranean attached four-car garage, swimming pool, and two retaining walls; the associated grading; and a haul route for the export of earth, on a lot located in a Single Permit Jurisdiction Area of the California Coastal Zone and appeal of the Categorical Exemption from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15303 and 15332.

There may be other time limits which also affect your ability to seek judicial review.
