PROPOSED PROJECT:

Hearing Held By:

The Project is the construction of a 1,862.5 square foot, two-story single-family dwelling on a vacant lot in the Northeast Hillside Ordinance area of the Northeast Los Angeles Community Plan Area.

REQUESTED ACTION(S):

- 1. The Zoning Administrator shall consider, pursuant to CEQA Guidelines Section 15074(b), the whole of the administrative record, including the Mitigated Negative Declaration, No. ENV-2014-3212-MND ("Mitigated Negative Declaration"), and all comments received.
- 2. Pursuant to Los Angeles Municipal Code (LAMC) Section 12.27, a Zone Variance (ZV) from [D] Development Limitation Number 1 of Ordinance 180,403 to allow a 34-foot envelope height for a portion of a single-family home, in lieu of the maximum 26 feet allowed.
- 3. Pursuant to Section 12.24 X.28 (a)(7)(i) of the LAMC, a Zoning Administrator's Determination (ZAD) to permit the construction, use, and maintenance of a new single-family dwelling fronting on a Substandard Hillside Limited Street (Ashland Avenue, which is unimproved), without providing the Minimum Adjacent Roadway width as required by LAMC Section 12.21 C.10(i)2.
- Pursuant to Section 12.24 X.28 (a)(7)(ii) of the LAMC, a Zoning Administrator's Determination (ZAD) to permit the construction, use and maintenance of a new single-family dwelling fronting on a Substandard Hillside Limited Street (Ashland Avenue and Thomas Street) that does not provide the Minimum 20-foot wide Continuous Paved Roadway from the driveway apron to the boundary of the Hillside Area, as required by LAMC Section 12.21 C.10(i)3.

5. Pursuant to Section 12.24 X.28 (a)(i) of the LAMC, a Zoning Administrator's Determination (ZAD) to permit a six (6)-foot side yard setback in lieu of the 11-foot side yard setback required by Section 12.21 C.10(a) of the LAMC.

If this matter is before a Commission, please note that a Recommendation Report will be available on-line seven (7) days prior to the hearing and will be accessible at planning.lacity.org, by selecting "Commissions & Hearings". Recommendation Reports are hyperlinked to the case numbers on the agendas. **Please note that Recommendation Reports** are not prepared for Hearing Officer or Zoning Administrator hearings.

TESTIMONY AND CORRESPONDENCE - Your attendance is optional; oral testimony can only be given at the public hearing and may be limited due to time constraints. Written testimony or evidentiary documentation may be submitted prior to the hearing. Decision-makers such as Associate Zoning Administrators or Commissions function in a quasi-judicial capacity and therefore, cannot be contacted directly. Any materials submitted to the Department or Commission become City property and will not be returned. This includes any correspondence or exhibits used as part of your testimony.

Be advised that the Commission may RECONSIDER and alter its action taken on items listed on the meeting agenda at any time during this meeting or during the next regular meeting, in accordance with the Commission Policies and Procedures and provided that the Commission retains jurisdiction over the case. If a Commission meeting is cancelled or adjourned due to lack of quorum, all remaining agenda items shall be continued to the next regular meeting or beyond, as long as the continuance is within the legal time limits of the case or cases.

REQUIREMENTS FOR SUBMISSION OF MATERIALS - Written testimony may be submitted via email, in person or by U.S. mail to the staff identified on the front of this page. Correspondence should be presented on letter size (8 ½ " x 11") or legal size (8 ½ " x 14") paper. All oversized exhibits <u>must be folded</u> to fit into a legal-sized folder. Plans (i.e. site plans, floor plans, grading plans) must be presented on paper size not smaller than ledger size (11" x 17"). The case number must be written on all communications, plans and exhibits.

Matters before Commissions:

- Regular Submissions Written materials not limited as to volume must be <u>received</u> by the Commission Executive Assistant no
 later than by end of business day Monday of the week prior to the week of the Commission meeting. Materials must be delivered
 electronically to the staff and Commission identified on the front of this page. In addition, an original plus six (6) copies must be
 submitted to the Commission Office directly at 200 North Spring Street, Room 532, Los Angeles, CA 90012 in attention to the
 Commission Secretariat.
- Rebuttal Submissions All written materials in response to a Recommendation Report and/or additional comments must be submitted no later than 48 hours before to the Commission Meeting (for Central, South LA and Harbor APCs, materials must be received no later than by 3:00 p.m., Thursday of the week prior to the Commission Meeting). Submissions, including exhibits, shall not exceed ten (10) pages and must be submitted electronically to the Commission identified on the front of this notice. Day of Hearing Submissions Submissions less than 48 hours prior to, and including the day of the public hearing, must not exceed two (2) written pages, including exhibits. Photographs do not count toward the page limitation.
- **Non-Complying Submissions** Submissions that do not comply with these rules will be stamped "File Copy. Non-complying Submission". Non-complying submissions will be placed into the official case file, but they will not be delivered to, or considered by the Commission. The Commission Rules and Operating Procedures are available online at planning.lacity.org by selecting "Commissions & Hearings" and selecting the specific Commission.

Matters before an Associate Zoning Administrator (AZA) or Hearing Officer: Written materials not limited as to volume must be <u>received</u> no later than **five (5) days** prior to the hearing date. Provide an **original** plus **(3) copies**, and follow the size guidelines above.

EXHAUSTION OF ADMINISTRATIVE REMEDIES AND JUDICIAL REVIEW - If you challenge these agenda items in court, you may be limited to raising only those issues you or someone else raised at the public hearing agenized here, or in written correspondence on these matters delivered to this agency at or prior to the public hearing. If you seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5, the petition for writ of mandate pursuant to that section must be filed no later than the 90th day following the date on which the City's decision became final pursuant to California Code of Civil Procedure Section 1094.6. There may be other time limits which also affect your ability to seek judicial review.
