## PROPOSED PROJECT:

A lot-tie of two adjacent lots, resulting in a single lot with a 15,721 square-foot two-story single-family dwelling with a basement and attached three-car garage, 2,742 square-foot one-story single-family dwelling with an attached two-car garage, 1,736 square-foot two-story guest house (with a kitchen), swimming pool, 564 square-foot pool house, tennis court, 222 square-foot tennis pavilion, and 157 square-foot tack barn on a 103.818 square-foot lot. The proposed project also involves the construction of a one-car carport for a total of six parking spaces on site, four covered and two uncovered.

### **REQUESTED ACTION(S):**

- The Zoning Administrator shall consider an exemption from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines. Section 15303 (Class 3), and that there is no substantial evidence demonstrating that an exception to a Categorical Exemption pursuant to CEQA Guidelines, Section 15300.2 applies.
- 2. Pursuant to Los Angeles Municipal Code (LAMC) Section 12.27, a Zone Variance (ZV) to allow the use and maintenance of three dwelling units on a lot in lieu of the one single-family dwelling otherwise allowed on a lot in the RE20-1-H Zone by LAMC Section 12.07.01.
- Pursuant to LAMC Section 12.28, a Zoning Administrator's Adjustment (ZAA) to allow the continued maintenance of a 4-foot-3-3/8-inch 3. northerly side yard setback for a lineal distance of 45 feet 7 inches in lieu of the 12 feet otherwise required by LAMC Section 12.21-C,10(a).

#### **GENERAL INFORMATION**

**FILE REVIEW -** The complete file is available for public inspection between the hours of 8:30 a.m. to 4:00 p.m., Monday through Friday. Please call or email the staff identified on the front page, at least three (3) days in advance to assure that the files will be available. **Files are not available for review the day of the hearing.** 

**TESTIMONY AND CORRESPONDENCE** - Your attendance is optional; oral testimony can only be given at the public hearing and may be limited due to time constraints. Written testimony or evidentiary documentation may be submitted prior to, or at the hearing. Decision-makers such as Associate Zoning Administrators function in a quasi-judicial capacity and therefore, cannot be contacted directly. Any materials submitted to the Department become City property and will not be returned. This includes any correspondence or exhibits used as part of your testimony.

REQUIREMENTS FOR SUBMISSION OF MATERIALS – Written materials may be submitted prior to the hearing via email, in person or by U.S. mail to the staff identified on the front of this page or to the decision-maker or hearing officer at the public hearing. An original plus three (3) copies must be submitted prior to, or at the hearing. To the extent possible, please also submit all materials electronically (flash drive, CD or via email). Materials must be presented on letter size (8 ½ " x 11") or legal size (8 ½ " x 14") paper. All oversized exhibits must be folded to fit into a legal-sized folder. Plans (i.e. site plans, floor plans, grading plans) must be presented on paper size not smaller than ledger size (11" x 17"). The case number must be written on all communications, plans and exhibits.

**EXHAUSTION OF ADMINISTRATIVE REMEDIES AND JUDICIAL REVIEW -** If you challenge these agenda items in court, you may be limited to raising only those issues you or someone else raised at the public hearing agenized here, or in written correspondence on these matters delivered to this agency at or prior to the public hearing. If you seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5, the petition for writ of mandate pursuant to that section must be filed no later than the 90th day following the date on which the City's decision became final pursuant to California Code of Civil Procedure Section 1094.6. There may be other time limits which also affect your ability to seek judicial review.

**ACCOMMODATIONS** - As a covered entity under Title II of the Americans with Disabilities Act, the City of Los Angeles does not discriminate on the basis of disability. The hearing facility and its parking are wheelchair accessible.
