PROPOSED PROJECT:

A Preliminary Parcel Map (Small Lot Subdivision) to subdivide one existing lot totaling approximately 5,200 square feet into two (2) new small lots that are 2,273 (Parcel A) and 2,527 (Parcel B) square feet in lot area – in conjunction with the demolition of an existing duplex and single-family dwelling, the removal of four trees, and the construction of a two-story, single-family dwelling with a roof deck on each newly subdivided lot, with residential floor areas of 2,181 (Unit A) and 1,740 square feet (Unit B). Six (6) parking spaces are provided onsite.

APPEAL:

An appeal of the Advisory Agency's determination to approve a Preliminary Parcel Map, pursuant to LAMC Sections 12.22 C.27 and 17.53.

An appeal of the Director of Planning's determination to approve a Coastal Development Permit and Mello Act Compliance Review, pursuant to Section 12.20.2 and Government Code Sections 65590 and 65590.1 and the City of Los Angeles Interim Mello Act Compliance Administrative Procedures.

If a Commission meeting is cancelled or adjourned due to lack of quorum, all remaining agenda items shall be continued to the next regular meeting or beyond, as long as the continuance is within the legal time limits of the case or cases.

TESTIMONY AND CORRESPONDENCE - Your attendance is optional; oral testimony can only be given at the Commission meeting and may be limited due to time constraints. If you seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5, the petition for writ of mandate pursuant to that section must be filed no later than the 90th day following the date on which the City's decision became final pursuant to California Code of Civil Procedure Section 1094.6. There may be other time limits which also affect your ability to seek judicial review.
