**REQUESTED ACTION:** The Zoning Administrator will consider:

- 1. A Coastal Development Permit, pursuant to the provisions of Section 12.20.2 of the Los Angeles Municipal Code, for the proposed demolition of an existing single-family residence with a detached garage, and the construction of a new two-story, 3,077 square-foot single-family dwelling with a maximum of 28 feet in height, with a detached two-car garage, located on a 3,150 square-foot lot in the R2-1 Zone, within the dual jurisdiction are of the California Coastal Zone, and Pursuant to the provisions of Section 11.5.7-C of the Los Angeles Municipal Code, a Specific Plan Project Permit from the Venice Coastal Zone Specific Plan.
- 2. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration (MND) for the above referenced project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**Exhaustion Of Administrative Remedies:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record.
