REQUESTED ACTION: The Zoning Administrator will consider:

- 1. Pursuant to the provisions of Section 12.24 X.28 of the Los Angeles Municipal Code, a Zoning Administrator's Determination to allow the construction of a new 3,396 square foot, two-story, 30-foot tall single family dwelling on a lot fronting on a Substandard Hillside Limited Street that is improved with a roadway width of less than 20 feet.
- 2. Pursuant to the provisions of Section 12.24 X.28 of the Los Angeles Municipal Code, a Zoning Administrator's Determination to allow the construction of a new single family dwelling on a lot not having vehicular access from a street improved with a minimum 20-foot wide continuous paved roadway from the driveway apron to the boundary of the hillside area.
- 3. Based on the whole of the administrative record, the Project is exempt pursuant to California Environmental Quality Act (CEQA) Guidelines, Section 21084, and City Exemption Class 3 Category 1

and Class 32, and there is no substantive evidence demonstrating that an exception to a Categorical Exemption pursuant to CEQA Guidelines, Section 15300.2 applies.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

<u>Exhaustion Of Administrative Remedies</u>: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.

<u>Advice To Public</u>: The exact time this report will be considered during the meeting is uncertain since there may be several other items on the agenda.
