PROPOSED PROJECT:	Construction, use, and maintenance of a new 12-unit apartment building, comprised of two levels of residential uses over one level of at-grade garage parking, with a maximum height of 45 feet, located on one lot totaling 21,822 square feet in area. The proposed building will provide a total of 24 automobile parking spaces. The requested entitlement is for a Zone Change from RA-1 to RD1.5-1, in conformance with the Low Medium II Residential land use designation of the Encino – Tarzana Community Plan.		

REQUESTED 1. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, **Adoption** of a proposed **Mitigated Negative Declaration** (ENV-2016-2080-MND) as the CEQA clearance document for the project; and

2. Pursuant to Los Angeles Municipal Code (LAMC) Section 12.32 F, a **Zone Change** from RA-1 (Single-Family Residential) to RD1.5-1 (Multi-Family Residential).

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The Hearing Officer will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations. <u>After the hearing, the Hearing Officer will prepare a report, including a recommendation, which will be considered by the decision maker, the South Valley Area Planning Commission, at a later date.</u>

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Department before the action on this matter, which will become a part of the administrative record. Note: This may not be the last hearing on this matter.
