**PROJECT LOCATION:** 2231 South Barrington Avenue Unit 100

**REQUESTED ACTION:** The Zoning Administrator will consider:

- 1. Pursuant to Section 12.24–W, 1, of the Los Angeles Municipal Code, a Conditional Use Permit to allow the sale and dispensing of a full line of alcoholic beverages for on-site and off-site consumption, in conjunction with a proposed 4,461 square-foot restaurant with 1,526 square-foot market, with 130 interior seats and 28 exterior seats in a proposed 703 square-foot outdoor uncovered patio area, with hours of operation from 7:00 a.m. to 11:00 p.m., Sunday thru Thursday and 7:00 a.m. to 12:00 a.m. Friday and Saturday; and
- 2. Pursuant to the provisions of Section 12.24-W, 27, of the Los Angeles Municipal Code, a Conditional Use Permit to allow the hours of operations of 7:00 a.m. to 12:00 a.m. in lieu of the hours 7:00 a.m. to 11:00 p.m. as restricted by Mini Shopping Center regulations.

3. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration (MND) for the above referenced project.

The purpose of this hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
