**PROJECT LOCATION:** 6320 - 6344 ½ N. Sepulveda Boulevard and 6335 N. Halbrent Avenue, legally described as Lot 1, Tract 28603, specifically shown in the application (see attached map).

## PROPOSED PROJECT:

The addition of 16 outdoor vacuum cleaner stations as an accessory use to an existing car wash, auto repair, and auto lube service, on a 1.2 acre site in the C2-1VL-RIO and P-1VL-RIO Zone. The requested entitlement is for a Zone Change from P-1VL-RIO to C2-1VL-RIO, in conformance with the General Commercial land use designation of the Van Nuys-North Sherman Oaks Community Plan and a Conditional Use Permit to allow the expansion of an auto related use (vacuum stations) within 500 feet of a residential use and to open at 8 a.m. on Saturday and Sunday in lieu of 9 a.m. and 11 a.m. otherwise required.

### **REQUESTED ACTION:**

- 1. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adoption of the proposed Mitigated Negative Declaration (ENV-2016-1345-MND) as the CEQA clearance document for the project; and
- 2. Pursuant to Los Angeles Municipal Code (LAMC) Section 12. 32 F, a Zone Change from P-1VL-RIO (parking zone) to C2-1VL-RIO (commercial zone); and
- 3. Pursuant to Los Angeles Municipal Code (LAMC) Section 12. 24 W.4, a Conditional Use to permit the expansion of an auto related use (vacuum cleaner stations) within 500 feet of a residential use or zone, and with proposed hours of operations from 8 a.m. to 6 p.m. daily.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The Hearing Officer will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations. After the hearing, the Hearing Officer will prepare a report, including a recommendation, which will be considered by the decision maker, the South Valley Area Planning Commission, at a later date.

**EXHAUSTION OF ADMINISTRATIVE REMEDIES:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Department before the action on this matter, which will become a part of the administrative record. Note: This may not be the last hearing on this matter.
