REQUESTED ACTION: The Zoning Administrator will consider:

- A Zoning Administrator's Adjustment per Section 12.28 of the Los Angeles Municipal Code, to allow a 4-foot 2-inch side yard setback in lieu of the 5-foot 2-inch side yard setback otherwise required by Section 12.09-C,2, in conjunction with the proposed demolition of a detached garage, and construction of a new detached garage with a second floor recreation room in the R2-1-O Zone.
- Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment. It shall therefore be exempt from the provisions of CEQA, under ENV-2016-4170-CE, pursuant to Article III, Section I, Class 3, Category 6 of the City of Los Angeles CEQA Guidelines.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing.

Exhaustion Of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record.
