PROJECT LOCATION:	701, 851, 861, N. Alma Real Drive, legally described as: Tract: Rancho Boca de Santa Monica, Lot: Pt allotment No 2 To Francisca M. De Rios, Arb: 41 and 43.
PROPOSED PROJECT:	The project involves the remodel of an existing public library with the addition of approximately 1,100 square feet of floor area for a total floor area of 12,185 square feet, and a maximum height of 13 feet, located on the western portion of the building.
REQUESTED ACTIONS:	1. Pursuant to Section 14.00-B of the Municipal Code, <b>Alternative Compliance for a</b> <b>Public Benefits Project</b> to permit the expansion of an existing public library to include an addition of approximately 1,100 square feet of floor area, with a maximum height of 13 feet, located on the western portion of the building.

2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of the California Environmental Quality Act (CEQA). Pursuant to Article III, Section I, Class 1, Category 5 of the City of Los Angeles CEQA Guidelines.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
