PROJECT LOCATION: 1901 W. Venice Boulevard

PROPOSED PROJECT: Located on the campus of Loyola High School of Los Angeles, the proposed project involves a Plan Approval to allow the demolition of an existing 17,160 square-foot auditorium and the construction, use, and maintenance of an approximately 36,240 square-foot auditorium (Xavier Hall). The project includes the relocation of two existing scoreboards, and the installation of eight new light poles to a maximum height of 100 feet. No change in enrollment or hours of operation of the existing High School are proposed. Existing parking will remain the same.

REQUESTED ACTIONS: 1. Pursuant to Los Angeles Municipal Code (LAMC) Section 12.24-M and Condition No. 27 of previously approved Case No. ZA-2003-6886(CU)(ZV)(SPR), a Plan Approval to permit: 1) the construction, use, and maintenance of an approximately 36,420 square-foot auditorium; 2) the installation and operation of two (2) 100-foot and two (2) 80-foot light

pole structures with light fixtures for the athletic field and four (4) 80-foot light pole structures with light fixtures for the baseball field; and 3) the relocation of an existing scoreboard for the swimming pool and the relocation of an existing scoreboard for the athletic field.

2. Pursuant to Section 15162 and 15164 of the State's Environmental Quality Act (CEQA) Guidelines consider the Addendum to the Mitigated Negative Declaration (ENV-2003-5573-MND-REC1) with the adopted Mitigated Negative Declaration ENV-2003-5573-MND (adopted on May 28, 2004) prior to making a decision on the Modified Project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
